South Africa	<ul> <li>Creation of a dedicated office to manage the public procurement program for IPP projects in the Ministry of Energy.</li> <li>Creation the Central Energy Fund (CEF) in 1977 playing a central role in ensuring South Africa's energy security.</li> <li>The National Energy Regulator of South Africa (NERSA) created in 2004 to regulate the electricity, gas, and petroleum pipeline industries.</li> <li>The National Nuclear Regulator (NNR) and the Nuclear Energy Corporation of South Africa (NECSA) created in 1999 to monitor and enforce regulatory safety standards for safe operating conditions and for the development and use of nuclear technologies.</li> <li>The National Radioactive Waste Disposal Institute (NRWDI) in 2009 to inform the public on all aspects of radioactive waste management.</li> <li>The South African National Energy Development Institute (SANEDI) created in 2011 to oversee R&amp;D in the energy sector and the promotion of green, low-carbon energy and energy efficiency.</li> </ul>	<ul> <li>The White Paper on Energy Policy of 1998, for access to affordable energy services for disadvantaged households, small businesses, farms and community services.</li> <li>The White Paper on Renewable Energy of 2004 to increase the share of renewable energy in the energy mix.</li> <li>The Integrated Resource Plan (IRP) 2010-2030, a long-term plan for building new electricity generation capacities.</li> <li>Introduction of pro-poor policies from 2000 including free basic electricity tariff, fully subsidizing 50KWh if a household consumes less than 450kWh</li> <li>Free Basic Alternative Energy in Rural Areas Policy, and the subsidy through an 'Inclining Block Tariff System'.</li> <li>The New Household Electrification Strategy (NHES) of 2013 providing 300,000 rural households with off-grid electrification.</li> </ul>	<ul> <li>Bridging the access gap for poor and rural communities.</li> <li>The Integrated National Electrification Programme (INEP) started in 2000 to merge off-grid solutions and alternative energy sources into the National Electrification program.</li> <li>Diversify energy supply through the Renewable Energy Independent Power Producers Procurement Programme (REIPPPP) started in 2011.</li> </ul>
