POSITION SUMMARY

AKADEMIYA2063 is an African non-profit research organization with headquarters in Kigali, Rwanda and a regional office in Dakar, Senegal. DUTIES & RESPONSIBILITIES

Under the direct supervision of the Director for Operational Support, the Senior SPS Scientist will perform the following duties:

- 1. Explore and evaluate priority SPS investments for implementing the AU SPS Policy Framework and Annex 7 of the African Continental Free Trade Area (AfCFTA) agreement
 - Review SPS and food safety related policy documents, research evidence, databases, and performance tracking tools at national, regional, and continental levels
 - Develop a typology of countries based on their institutional, human, and physical infrastructure capacities for implementing SPS regulatory systems and requirements
 - Lead effort to collect data on SPS compliance costs, investment needs and costs in five target countries
 - Assess the cost of SPS compliance and identify the institutional, human, and physical infrastructure investment needs and priorities for improving SPS compliance and for an effective implementation of SPS measures and the AU SPS Policy Framework at country, regional and continental levels
 - Evaluate costs and benefits of SPS investments in boosting intra-Africa agricultural trade, increasing agricultural productivity, and reducing health risks and costs
 - Prioritize SPS investments using available prioritization tools such as Prioritizing SPS Investments for Market Access (P-IMA)

2. Conduct analysis on food safety in Africa

- Conduct a detailed review and analysis of the CAADP Biennial Review (BR) food safety data including data gaps and reporting challenges
- Examine the status, challenges, and best practices in food safety, and explore policy reform options and capacity building required for an effective implementation of the AU SPS policy framework

3. Provide knowledge sharing and performance tracking tool development support to AUC-DARBE

- Support organization of regional dialogues and learning events to promote coordination of SPS policies, mutual learning on SPS experiences and best practices among AU Member States, and coordinate with the Senior SPS Advisor to deliver messaging on food safety
- In collaboration with other partners, organize trainings on data collection, analysis and tracking tools to build the implementation capacities in RECs and AU Member States
- Contribute to the development of tools for tracking SPS implementation progress by AU Member States
- Contribute to the development of an SPS index to be included in the CAADP BR report
- Collect and analyze data on capacity building activities and share findings

- PhD in Agricultural Economics, Economics, International Trade, Agribusiness, Food Safety, Development Studies, or closely related field
- At least 10 years of relevant professional experience working on food safety and SPS measures
- Proven experience on **strategic and policy research** related to food safety, or plant and animal health
