# CONCEPT NOTE

## 1. Background

The 2025 African Union Biennial Review (BR) Report on the Comprehensive Africa Agriculture Development Programme (CAADP) marks a critical milestone in Africa's agricultural transformation agenda. As the continent advances implementation of CAADP under the Kampala Declaration, the BR continues to serve as Africa's flagship mutual accountability mechanism: tracking progress, identifying gaps, and fostering peer learning across Member States.

The 2025 BR report provides updated evidence on performance across key CAADP commitments, including agricultural investment, productivity growth, trade, resilience, and food security. While the BR is widely recognized as a robust monitoring tool, its true potential lies beyond reporting: it can serve as a strategic instrument to guide policy reform, prioritize investments, strengthen delivery systems, and improve coordination at national and regional levels.

This webinar will unpack the key findings of the 2025 BR and explore how governments, Regional Economic Communities (RECs), development partners, research institutions, and the private sector can more effectively use BR evidence to inform planning, budgeting, implementation, and accountability processes. The discussion will move from "what the data show" to "what must be done differently" and will contribute to ongoing continental dialogue on strengthening CAADP implementation in the lead-up to the next CAADP strategic phase. It aims to equip policymakers and stakeholders with actionable insights to translate BR findings into accelerated impact.

## 2. Objectives and Expected Outcomes

**The webinar aims to address some of the following questions:**

1. What are the most critical challenges and implementation gaps identified in the 2025 BR?
2. Why do some countries consistently perform better, and what lessons can be replicated?
3. How can the BR be effectively linked to national planning and budget cycles and integrated into the agriculture Joint Sector Reviews (JSRs)?
4. What incentives and accountability mechanisms can strengthen uptake of BR and results, as well as follow-through after BR reporting?
5. How can development partners align financing and technical support with BR-identified priorities?
6. What are the biggest lessons to be learnt from the BR process as we enter the next 10-year phase of CAADP implementation?
7. What role can and should CSOs play in holding their governments accountable?
